- 4. Cost of College – copy of 2010/11 college literature which indicates a breakdown of costs (tuition, room and board, mandatory fees.)**
- 5. CSS/Financial Aid PROFILE – MHS School Code # 0672.**
- 6. Transcript and SATs and/or ACT (provided by MHS for MHS students).**
- 7. Copy of your financial aid award letter which you have completed and signed for the college you are attending.**
